INTRODUCTION


When considering housing, many individuals and families in Canada must also consider the needs of their pet(s) when identifying appropriate housing. For individuals and families who rent properties, this often means identifying rental units that do not have “no pet” policies, which can be time consuming and difficult. For Indigenous Women, Girls, Two-Spirit, Transgender, and Gender-Diverse+ (WG2STGD+) People, who already face systemic barriers to accessing housing, identifying pet friendly housing accommodations is even more straining. Moreover, for Indigenous WG2STGD+ People fleeing abusive relationships, finding a place to safely house their pet(s) can be almost impossible.

The purpose of this toolkit is to provide Indigenous WG2STGD+ People with valuable information regarding pet(s) in housing. This document functions as a tool to help identify housing rules and supports for Indigenous WG2STGD+ People in accessing pet friendly housing.

CAN A LANDLORD REFUSE TO RENT TO ME FOR HAVING A PET?

Yes, in all provinces and territories landlords may choose not to rent to individuals and families with pet(s). In these instances, the landlord may decide not to enter into a rental agreement should an individual indicate that they have a pet(s).

Across Canada, landlords are prohibited from refusing to rent to an individual with a service animal. Generally, landlords can ask tenants if their service animal is trained to assist with a disability; however, a landlords cannot ask questions pertaining to a person’s disability or ask for the service animal to demonstrate its capabilities. Should further questions pertaining to the rights of a tenant and their service animal, individuals should consult their provincial/territorial Human Rights Commission:

My lease has a “no pet” rule. What can I do to try and convince a potential landlord to let me bring my pet?

Unfortunately, it may be difficult to convince a landlord to change their policies on pets. However, there are a few things to consider when trying to convince your landlord to allow pets:

- Create a resume for your pet documenting its training and behaviours.
- Ask previous landlords, animal trainers, and your veterinarian to function as references for your pet.
- Have your pet spayed/neutered and ensure your pet has received any necessary vaccinations.
- Consider introducing your pet to the landlord to show off the pets’ qualities.

However, despite your best-efforts, landlords may still refuse pets in the rental unit. At this point it may be worth considering trying to find another rental property.

CAN MY LANDLORD PREVENT ME FROM HAVING A PET AFTER I SIGN MY LEASE?



It is important for tenants to carefully read and fully understand terms and conditions listed in the rental agreement. The agreement will often outline a landlord’s policy pertaining to pets and describe conditions in which a tenant may house a pet. In all provinces except Ontario, landlords are allowed to prohibit tenants from having pets in the rental property. Landlords can restrict pets based on their size and type, as well as the number of pets allowed in each rental unit. If a tenant breaks a condition in the rental agreement related to pets, they may be subject to eviction from the rental property.

In Ontario, the standard lease outlines that landlords may not prohibit tenants from having pets in the rental unit. However, landlords in Ontario can evict a tenant due to their pet(s) through the Landlord and Tenant Board. Landlords in Ontario may evict tenants with pets if:

- The pet is making too much noise.
- The pet is causing damage to the property.





- The pet is causing other tenants to have allergic reactions.
- The animal species/breed is determined to be dangerous.
- The rules of the condominium do not allow pets¹

Should a landlord in Ontario try to prevent a tenant from having a pet in a rental property, the tenant can contact the **Landlord and Tenant Board** to file a complaint.



CAN MY LANDLORD CHARGE A PET DEPOSIT OR FEES?

Each province and territory have distinct rules pertaining to the collection of pet deposits or fees. In British Columbia, Saskatchewan, Manitoba, and Northwest Territories, landlords are allowed to collect additional pet deposits, as outlined below:

Province:	Pet Deposit Rules:
British Columbia:	Must be requested at the start of tenancy and can be no more than half of one month's rent. ²
Saskatchewan:	A deposit can be included with a security deposit; however, cannot exceed one month's rent. ³
Manitoba:	Pet damage deposit cannot be more than one month's rent, with the landlord being able to claim the deposit for damage and cleaning costs associated with the pet. ⁴
Northwest Territories:	Landlords can require pet deposits equal to 50 percent of one month's rent. ⁵

In Alberta, Saskatchewan, and Yukon Territory, landlords are allowed to charge tenants pet-related fees, which can be fully refundable following the end of tenancy. In Alberta, pet fees cannot be greater than the first month's rent, while in Saskatchewan and Yukon Territory these fees may be charged monthly. Any fee or pet deposit must be outlined and agreed to in the rental agreement.

In Ontario, Quebec, New Brunswick, Nova Scotia, Newfoundland and Labrador, PEI, and Nunavut, landlords are prohibited from charging pet deposits.

WHAT CAN I DO WITH MY PET IF I AM LEAVING AN ABUSIVE PARTNER?

Individuals leaving abusive relationships face significant barriers to leaving their abuser, which can include barriers associated with their pet's safety. In many instances, individuals experiencing abuse may fear what their abuser may do to their pet if they leave, which leads many to delay leaving their abuser or even returning to live with their abuser to protect their pet(s).⁶ Fear for what might happen to a pet when leaving an abuser is completely normal. It is important to plan accordingly when preparing to leave an abuser. Some things individuals can do when preparing to leave with their pets include:

- Taking steps to prove ownership by updating licenses and vaccine records under your name.
- Removing your partner as a contact if your pet is microchipped.
- Identifying new veterinarians who can be used after leaving an abuser.
- Speaking with family, friends, and pet services about temporary care options.⁷

In addition to making a safety plan that includes your pet, it is equally important to create a checklist of what to bring when leaving with your pet. The checklist below outlines the

type of items pet owners should bring when leaving their abuser:

It is recommended that after leaving an abuser, pet owners keep their pets indoors as much as possible and avoid letting their pet out alone. This can prevent an abuser from taking back a pet and causing further harm to the victim.

WHAT IF I HAD TO LEAVE MY PET BEHIND?

In the event a victim has left their abuser and was not able to bring their pet, they should consider seeking the assistance of law enforcement to intervene and return their pet. Law enforcement agencies may require individuals provide proof of ownership to intervene. In doing so, survivors may have to provide proof of ownership, pet licenses, and veterinarian bills to prove their ownership over the animal.

What can I do if I cannot find housing for my pet?

If family or friends are unable to care for your pet when leaving an abusive situation, there may be other options survivors can use to safely house their pets. In every province and territory, **except for the Northwest Territories and Nunavut**, shelters and pet safekeeping programs offer important resources for individuals leaving an abusers. Unfortunately, many of these programs still rely on offsite foster programs to care for pets and have limited capacities. As many programs continue to offer offsite support, this means survivors may not have access to their pets, while the pet is in the program.

When creating a safety plan for yourself, and your pet, survivors should reach out to local services to see if they are currently taking pets. In some instances, shelters may not be accepting pets as other survivors or staff may have allergies to specific animals or pet safekeeping programs are at capacity. Below is a list of resources and shelters that provide support for pets of people fleeing abuse:
