
#### PRESIDENT'S REPORT - JANUARY

Happy New Year to all! As 2023 begins, I extend warm wishes for a happy and prosperous year to the staff and delegates of the Native Women's Association of Canada (NWAC). I recently spent time with my family, reflecting on our stolen sisters and those who were unable to celebrate the holidays with their loved ones. This drives my passion to advocate for the political voice of Indigenous women, girls, and gender-diverse individuals in Canada, including First Nations, Métis, Inuit, and those with and without status.

The year started off on a strong note with the Roundtable of Indigenous Leaders and Representatives and Federal-Provincial-Territorial Governments on Missing and Murdered Indigenous Women, Girls, and 2SLGBTQI+ People, hosted by Minister Miller of CIRNAC.



The president remarked on the timeliness and importance for bringing together leaders among all jurisdictions. She noted that this is a great platform to work together and that there is much work to be done to enable more supports to end suffering among our families. She also highlighted the Safe Passages webbased project as one of the exciting new initiatives being developed by NWAC which takes a survivor-centred approach. In addition, the President highlighted the work taking place to establish much-needed Resiliency Lodges across the country. Initiatives such as these are focused on safety, security and healing for the people we serve. She also remarked about the importance of urban Indigenous issues which she was pleased to see on the agenda.

The roundtable was intended to help advance the development of a "collaborative, coordinated approach" among Indigenous leaders and representatives and Federal, Provincial, and Territorial governments. At a News conference following the meeting, Minister Miller announced that Jennifer Moore Rattray, the former Executive Director of the National Inquiry into Missing and Murdered Indigenous Women and Girls, would fill the role of ministerial special representative who will be tasked with providing recommendations for the creation of an Indigenous and human rights ombudsperson. This is a step in the right direction. However, NWAC will be monitoring timelines as implementing the MMIWG Calls for Justice is an urgent priority.

In January, I was also able to produce my 23-year workplan. We pulled inspiration directly from our strategic plan, as well as the NWAC-Canada Accord. The work plan aligns the Board of Directors priorities as well as NWAC's action plan – Our Call, Our Actions. Our top goals are good governance, to ramp up lobbying efforts to ensure stable core funding and capacity building for our PTMAs.

I was able to revamp my coffee chats with Carol sessions and have started my second round of meetings with all of our PTMAs. I met with Denise Cook, Co-President of Manitoba Moon Voices. We had a meaningful discission. Denise was able to provide us with a quote for our social media surrounding a funding announcement in Manitoba which is an Indigenous-led rapid access to addictions medicine (RAAM) clinic in downtown Winnipeg.


