## PRESIDENT'S REPORT

I started the month of **August** with an in person visit with my local Member of Parliament who represents the riding of Nipissing—Timiskaming - Anthony Rota. Anthony Rota is the 37th and current speaker of the House of Commons of Canada since 2019. We discussed areas of mutual concern. I advised him of NWAC's current programs such as the National Apprenticeship program and Safe Passage. I also extended an invitation to NWAC's headquarters . <u>We will be</u> meeting on October 6, 2023.

On Saturday August 12, 2023, our office attended the 49th Annual General Assembly in person. It was a pleasure to report to and hear from our membership. The meeting was a great success as by- law changes were passed (among other important business). The theme this year was reconciliation, which is an important endeavor for my office. We consistently lobby the federal government to reconcile their approach to include NWAC and Indigenous women ways of knowing at decision making tables.

PRESIDENT'S Report

On August 17, myself and my interim adviser virtually met with the new Minister of Crown-Indigenous Relations, Gary Anandasangaree. I spoke about NWAC's top priorities as it relates to his department such as keeping promises under *the NWAC-Canada Accord*, Winnipeg landfill search, MMIWG priorities specifically an amber alert, advocating against the government's distinctions-based approach to decision making and PTMA capacity building and issues affecting communities (housing, education, ect). I also extended an invitation to the Minister to visit NWAC's headquarters so that we can continue our conversation.

Much of August was spent planning for the busy fall when both Houses will be in full swing. There is a lot of planning involved, especially this year with Parliamentarians on the campaign trail. In fact, our office met with the CEO's office for a two-day planning session that proved to be very fruitful.
